

Plantagenet Descendant Chart From Henry III, King of England

There exists, today, countless numbers of descendants of the Plantagenet line, and many in America are descended from King Edward III. The Rowe and Clegg family lineage compiled from various sources by Secrets in the Wind, House of Plantagenet.

Henry III Plantagenet, King of England 1 October 1207 at Winchester Castle, Winchester, Hampshire, England and died 16 November 1272 at the Palace of Westminster, Westminster, England. He was buried 20 November 1272 at Westminster Abbey, Westminster, Middlesex, England. He married Eleanor de Provence 14 January 1236 at Canterbury Cathedral, Canterbury, Kent, England. He was 28 and she was 12 years old. The reign of Henry III lasted from 28 October 1216 until his death. His coronation was held on 28 October 1216 at Gloucester Cathedral and 17 May 1220 at Westminster Abbey. *“Henry was known for his public demonstrations of piety, and appears to have been genuinely devout.”¹ He promoted rich, luxurious Church services, and, unusually for the period, attended mass at least once a day.² He gave generously to religious causes, paid for the feeding of 500 paupers each day and helped orphans. He fasted before commemorating Edward the Confessor's feasts, and may have washed the feet of lepers.³ Henry regularly went on pilgrimages, particularly to the abbeys of Bromholm, St Albans and Walsingham Priory.”*

Edward I Plantagenet, “Longshanks,” King of England b. 17 June 1239 at the Palace of Westminster, Westminster, Middlesex, England and died 7 July 1307 at Burgh by Sands, Cumberland, England. He was buried 28 October 1307 at Westminster Abbey,

Westminster, Middlesex, England. He married Eleanor de Castille on 18 October 1254 at Westminster Abbey, Westminster, London, England. She was born 10 January 1241 at Burgos, Provincia de Burgos, Castilla y León, Spain and died 28 November 1290 at Hereby, Lincolnshire, England. Edward I grieved for her, his devotion outlasting their marriage. He had been always faithful to her. After her death, in 1299 he married Margaret of France, so as to satisfy peace between England and France. The reign of Edward I Plantagenet lasted from 1272 until his death.

Edward II Plantagenet, King of England b. 25 April 1284 at Caernarvon Castle, Caernarfonshire, Wales d. 21 September 1327 Berkeley Castle, Berkeley, Gloucestershire, England. He was buried 20 December 1327 at Gloucester Cathedral, Gloucestershire, England. He married Isabella of France 25 January 1308 at Boulogne-sur-Mer, Pas-de-Calais, France, the daughter of King Phillip IV. Isabella was b. 2 August 1295 at Paris, Île-de-France, France and died 22 August 1358 at Hertford Castle, Hertfordshire, England. Edward II's reign existed from 7 January 1307 to 25 January 1327. Isabella began an affair with Roger Mortimer, 1st Earl of March, as the king was believed to have been homosexual, having had assumed affairs with Piers Gaveston and, after Gaveston's death, Hugh DeSpencer, the Younger. Isabella and the exiled Mortimer pulled together an army and invaded England in 1326. Edward's reign

collapsed and he fled to Wales where he was captured in November and forced to relinquish his crown to his son, Edward III, who was around 15 years old at the time. It is believed Edward II was murdered.

Edward III Plantagenet, King of England a/k/a Edward of Windsor was born 13 November 1312 at Windsor Castle, Berkshire, England and died 21 June 1377 at Sheen Palace, Richmond, London, England. He was buried 5 July 1377 Westminster Abbey, Westminster, Middlesex, England. On 24 January 1327, at Yorkshire, England, he married Philippa de Hainault b. 24 June 1310 Comté de Hainaut, Holy Roman Empire and died 14 August 1369 at Windsor Castle, Windsor, Berkshire, England. Edward III, King of England, reigned from January 1327 until his death, at the time the longest reign of a king in history.

John “of Gaunt” Plantagenet, 1st Duke of Lancaster, 4th son of King Edward iii of England b. 6 March 1340 at Saint Bavo's Abbey, Ghent, Flanders, Belgium⁴ d. 3 February 1399 at Leicester Castle, Leicestershire, England. He was buried 15 March 1399 at St. Paul's Cathedral, London. He married three times and had several mistresses, the last being mistress, Catherine de Roet whom he married after his 2nd wife, Constance, died. John's marriage to Catherine was “ratified and confirmed during the Great Schism by the Roman pope, Boniface IX, on 13 January 1396.” She was the daughter of Sir Payne de Roët. They were married at Lincoln Cathedral, Lincoln, Lincolnshire, England; his 3rd (widower).⁵ Catherine was b. 25 November 1350, Somme, Picardie, France, and died 10 May 1403 at They, Meurth-et-Moselle, Lorraine, France. She was buried May 1403 at Lincoln Cathedral, Lincoln, Lincolnshire, England. Catherine changed the spelling of her name to “Kathryn/Katherine” and changed her surname to “Swynford” after their marriage and when she became the Duchess of Lancaster. The couple's children (shown below as specific to this line) were born before the marriage, and were legitimised in 1397, during the reign of the Duke's nephew, King Richard II. John of Gaunt founded the House of Lancaster, and his great-granddaughter, Margaret Beaufort, was the mother of Lancastrian King Henry VII, the murderer of Richard iii at the Battle of Bosworth. John of Gaunt was the father of Henry IV, King of England.

He died 21 Oct 1425, Raby Castle, Durham, England buried October 1425 Collegiate Church of St. Mary, Staindrop, Durham, England. He married three times: (1) Margaret Stafford ca 1382 and (2) Joan de Beaufort, Countess of Westmoreland on 29 Nov 1396 at Meuse-et-Loire, France. The chart will show the children by Joan as it relates to the descendants herein.

Sir George Neville, 1st Baron Latimer b. 1414, Raby, Durham, England d. 30 December 1469 Well, Yorkshire, England, buried 31 December 1469 St Michael's, Well, North Yorkshire, England. He Married Lady Elizabeth de Beauchamp b.16 September 1417 Warwick Castle, Warwick, Warwickshire, England d. 26 Sep 1480 buried St.Mary's, Warwick, Warwickshire, England, 2 October 1480. She was the daughter of Richard de Beauchamp, 5th Earl of Warwick and Elizabeth Berkeley. BEF Feb 1436/37, Warwick Castle, Warwickshire, England. Toward the end of his life, they say Sir George was mentally incompetent though at times lucid.

Margaret Neville b. 9 March 1495 at Snape Castle, Yorkshire, England d. 23 October 1532 at Snape, Yorkshire, England. Margaret sometimes went by the name of Margaret Latimer, for her father, Richard Neville, 2^d Baron Latimer. Her mother was Lady Anne Stafford. Some sources say that Margaret died childless, however, the discrepancies are in the parents of Margaret which are Richard Neville and Ann Stafford and not Sir John Neville and Lady Dorothy de Vere. Margaret was the wife of Edward Willoughby, 3rd Baron Willoughby of de Broke and mother of Elizabeth Willoughby Greville. Margaret married Edward Willoughby by dispensation on 22 November 1505. Edward died in 1517 leaving three daughters, two of whom died young. (sources: various Peerage information)

Sir Fulke Greville, Knt. b. 28 Apr 1491 at Milcote, Warwickshire, England d. 10 November 1559 at Alcester, Warwickshire, England and was buried 21 December 1559 at St. Nicholas Churchyard, Alcester, Stratford-on-Avon District, Warwickshire, England. He married Elizabeth Willoughby b. 28 April 1510 Brokenborough, Wiltshire, England, the daughter of Edward Willoughby and **Margaret Neville**. She died 15 November 1562 at Alcester, Warwickshire, England and is buried alongside her husband. After Elizabeth's father died in 1517, she became the ward of Sir Edward Greville in 1522 who later married her to his second son, Fulke. Elizabeth agreed as she was not in favor of marrying Fulke's older brother, John.

Frances Mary Greville was born ca 1598 in Essex, England. She was married three times, the last being Samuel Matthews Sr. She immigrated to Jamestown, Virginia in 1620 possibly with her first husband. She married Samuel ca. 1629.

Samuel Matthews was born ca 1600 “probably in England. He came to Virginia before 1618 as a servant to Sheriff Johnson of London. He was first in James Towne but went to live in Sherley hundred.

Samuel was first married to **Frances Greville** after 24 Mar 1627. Frances was born in England and came to Virginia in the Supply when she was less than 20 years old in 1620. She was first married to Nathaniel West by whom she had a son named Nathaniel and later to Abraham Piersey.”

Reuben Holloway b. 1740 in Virginia and d. 6 October 1806 in Edgefield, South Carolina. He married **Peninah Jordan** b. 1745 d. 1820 ca. 1774.⁷ Reuben is buried in the Holloway Family Cemetery in Ninety-Six, Greenwood County, SC. He was a Revolutionary War soldier.⁸ Both Reuben and Peninah had been married twice. Peninah appears to have married Shadrack Stanley after Reuben's death in 1806, judging by the birthdates of their children. A J.W. Stanley Bible entry shows that Shadrack Stanley had married “unknown Moon” or “Moor” after 1820 in Alabama. Since Peninah died in 1820, it would appear that Shadrack remarried after that date, as indicated. The name of the father of Peninah's children is questioned by the Stanley family. as though they are also not certain of Shadrack's marriage to Peninah. The following list of children, males only, are named in the Bond Agreement between Peninah Holloway and Jesse Holloway,⁹ a nephew of Reuben, (who is most likely the husband of Catherine Jordan, originally thought to be Reuben's wife)
